Emissions reduction targets

Seelingo have reduced their total emissions by 28.18% by end of 2022/23 compared to our baseline year of 2021/22, equivalent to a reduction of 4.514 tonnes CO₂e. This has been achieved by increasing the amount of renewable electricity we buy and generate on site, decreasing by 39.06% of the total electricity we source and through our energy efficiency programme.

We are currently gathering data on our Scope 3 emissions to ensure that we have a robust baseline upon which to build our reduction targets. We expect to use 2022-23 as our new baseline for Scope 1, 2 and 3 emissions and intend to bring forward our target date for achieving NetZero from 2040, once we have a firm baseline established.

Over the next five years we plan to implement further measures which will continue to drive down emissions. We are considering several initiatives and those listed below are some examples of areas we are discussing.

1. Carbon Footprint Assessment.
 - a. Conduct an Initial Assessment: We will conduct a comprehensive assessment of our carbon footprint, including direct emissions from our operations (scope 1 emissions) and indirect emissions from purchased electricity, business travel and supply chain activities (scope 2 and scope 3 emissions).
 - b. Identify Hotspots: Based on the assessment, we will identify key areas where our carbon emissions are most significant and prioritize them for emissions reduction efforts.
2. Energy Efficiency and Renewable Energy.
 - a. Improve Energy Efficiency: We will implement energy-saving measures to reduce energy consumption in our facilities, such as using energy-efficient lighting, optimizing heating and cooling systems and promoting energy-conscious behaviours among employees.
 - b. Renewable Energy Sources: We will explore and invest in renewable energy sources, such as solar panels or purchasing renewable energy credits, to transition to a cleaner energy supply.
3. Sustainable Transportation and Logistics.
 - a. Fleet Management: We will optimize our transportation fleet by adopting fuel-efficient vehicles, utilizing alternative fuels where possible and implementing efficient route planning and

- b. Sustainable Packaging and Logistics: We will prioritize the use of eco-friendly packaging materials and implement sustainable logistics practices, such as optimizing packaging sizes, using returnable/reusable packaging and partnering with logistics providers that prioritize carbon reduction.
4. Supply Chain Management.
- a. Supplier Engagement: We will engage with our suppliers to encourage them to reduce their carbon emissions and adopt sustainable practices. We will prioritize working with suppliers that demonstrate a commitment to environmental responsibility and carbon reduction.
- b. Life-cycle Assessment: We will evaluate the carbon footprint of the medical consumables we trade and work with suppliers to identify opportunities for emissions reductions throughout the product life-cycle, including raw material sourcing, manufacturing, transportation, use and end-of-life management.
5. Employee Engagement and Education.
- a. Awareness and Training: We will provide training and awareness programs to our employees, educating them about the importance of carbon reduction and promoting environmentally responsible behaviours both at work and in their personal lives.
- b. Employee Involvement: We will encourage employee participation in carbon reduction initiatives and solicit ideas and suggestions to improve our environmental performance.
6. Monitoring and Reporting.
- a. Tracking and Metrics: We will implement systems to accurately track and monitor our carbon emissions, setting measurable targets for reduction and regularly reporting on our progress.
- b. Annual Reporting: We will publish an annual sustainability report, detailing our carbon reduction efforts, achievements, challenges and future goals. This report will promote transparency and accountability to our stakeholders.
7. Continuous Improvement.
- a. Innovation and Technology: We will stay informed about advancements in carbon reduction technologies and practices, embracing innovative solutions that can further minimize our environmental impact.
- b. Collaboration and Partnerships: We will actively seek collaboration and partnerships with
